

4. Inter-Seniority of above officers will be fixed later on.
5. The above officers are allocated to their present Commissionerates on promotion. Joining reports and refusal if any should be sent to the undersigned and all concerned without fail.
6. The above officers should join on promotion in their new posting latest by 20-03-2024 without fail. If any officer fails to join by 20-03-2024, it will be deemed as her/his refusal and the promotion order will be cancelled without any further intimation. They will not be considered for promotion before completion of one year from the date of such refusal.
7. The promotee have to exercise the option for fixation of pay under provision of Rule F.R.22(I)(a)(1) within the prescribed period of one month of their joining on promotion. If the officer has already been granted 1<sup>st</sup> / 2<sup>nd</sup> or 3<sup>rd</sup> Financial upgradation under MACP Scheme he/she will not be eligible for grant of increment or pay fixation benefits on promotion.
8. The Joining report should be sent to the undersigned and all concerned by 20<sup>th</sup> March 2024 without fail.


